ORGANIZATION: MEANS TO AN END OR JUST THE END

- In his book *Harvest of Humanity*, John Seamands tells this story: "A German soldier was wounded. He was ordered to go to the military hospital for treatment. When he arrived at the large and imposing building, he saw two doors, one marked, 'For the slightly wounded,' and the other, 'For the seriously wounded.'"
- "He entered through the first door and found himself going down a long hall. At the end of it were two more doors, one marked, 'For officers', and the other, 'For non-officers.' He entered through the latter and found himself going down another long hall. At the end of it were two more doors, one marked, 'For party members' and the other, 'For non-party members.' He took the second door, and when he opened it he found himself out on the street."
- "When the soldier returned home, his mother asked him, 'How did you get along at the hospital?' 'Well, Mother,' he replied, 'to tell the truth, the people there didn't do anything for me, but you ought to see the tremendous organization they have!'"

AT THE END OF THE STORY ALL HE COULD CONCLUDE WAS, "WHAT A GREAT ORGANIZATION IT WAS". NOT WHAT A GREAT ORGANIZATION HAD ACCOMPLISHED FOR HIM... . IT REALLY DIDN'T SERVE ANY LARGER PURPOSE

ORGANIZATION DOESN'T EXIST FOR ITSELF BUT TO ACCOMPLISH SOMETHING! WHY DOES THE ORGANIZATION OF THE CHURCH EXIST? WHY VESTRIES, WARDENS, AND PARISH COUNCILS?

IT'S ABOUT SPREADING THE GOSPEL OF JESUS CHRIST!

It's all about more than than it's all about!

CONSIDER THE FOLLOWING IN THE SCRIPTURES:

- "Now at that time while the disciples were increasing, complaint arose on the part of the Hellenistic Jews against the native Hebrews, because their widows were being overlooked in the daily serving of food" (Acts 6:1)
- "So the twelve summoned the disciples and said . . . Select from you seven good men of reputation . . . " The First Deacons (6:5)
- "And the Word of God kept on spreading, and the disciples continued to increase greatly in Jerusalem and a great many priest were becoming obedient to the faith" (Acts 6:7)

BEGIN EVERY MEETING OF ANY KIND WITH YOUR MISSION STATEMENT!




HOW IT WORKS OUT WITHIN THE HIERARCHICAL STRUCTURE OF ANGLICANISM

The Anglican Hierarchy is top down and bottom up!

- It's not exclusively top down like other catholic and protestant systems . . .
- It's not exclusively bottom up like congregationalist systems . . .
- It's a both/and with bishops in elected by people, consecrated by historic bishop in succession to the apostles, who are constitutionally bound, and who work pastorally within the consensus of clergy and laity

Other Ministries:, Benevolence Fund; Evangelism/Outreach; Hospitality; Counseling, Daycare, etc... Ideally, every parish member ought to be involved with at least one ministry fo the parish.

THREE KEY WORDS ABOUT ANGLICAN ORGANIZATION & STRUCTURE TO KEEP IN MIND:

Conciliarity

Consensus

Subsidiarity

- The church exists in council with all of its parts . . . In a symmetry at each level.
- The parts work with, not apart from the whole . . . The whole works with not apart from the parts . . . Clergy and laity working together to grow the kingdom, facilitate ministry, and help people come to Jesus Christ.
- "The principle that a central authority should have a subsidiary function performing only those tasks which cannot be performed at a local level" Oxford English Dictionary.

The organizational parts do not exist as an end in and of themselves . . . But they exist to grow of the Kingdom of God, facilitate ministry, and reach people for Jesus Christ!

CHURCH ORGANIZATIONAL STRUCTURES ARE ALWAYS TO BE . . . ALL ABOUT MORE THAN THEY ARE ALL ABOUT!
